## Visa for skilled workers with vocational training qualification

As a skilled worker with vocational training qualification, you can be issued a residence permit to engage in skilled employment that your qualification enables you to perform.

Please note that some university degrees from foreign universities are classified as vocational training qualifications in Germany.

### The following documents are to be submitted in full with every application:

- 2 fully completed and signed applications including declarations pursuant to Section 54 Residence Act
- 2 recent biometric passport photos (see specimen photos)
- Valid passport with at least two completely empty pages
- 2 uncertified copies of the data page of your valid passport
- Danish residence permit (card) – original + 2 copies (front and back)
- Proof of address in Denmark: yellow Danish health card (sygesikring) or bopælsattest (not older than 2 months) – original + 2 copies
- Completed form signed by your employer: [Declaration of employment](#) (in German) original + 2 copies
- Job description from your employer – original + 2 copies
- From the age of 45: Proof of adequate provision for old age – original + 2 copies – only if salary does not amount to at least 55% of the annual contribution assessment ceiling for the general pension insurance scheme – 2023: 48.180 € gross/per annum
- Notification of recognition of foreign vocational training:** Written notification of the agency responsible for recognition of vocations in Germany – original + 2 copies

*or (in the case of regulated professions in which permission is required to exercise the profession, for example, in the care sector; complete list is available from the [Federal Employment Agency](#) or the [European Commission](#))*

**Permission to exercise a profession** issued by the authority responsible for recognising

qualifications or assurance of permission to exercise a profession (original and two (2) copies) (for example, for medical professions)

- Proof of qualification, for example, diplomas, certificates, work log and proof of completion with certified German translation, if not in English – original + 2 copies.
  
- Proof of adequate health insurance cover  
If as an employee you are subject to mandatory statutory health insurance, you must bear in mind that this insurance can only begin when you take up residence in Germany and enter into employment. If you enter Germany beforehand, private health insurance must be taken out for the period prior to employment beginning and prior to being eligible for statutory health insurance. In its terms and conditions, travel health insurance can exclude protection if a long-term or permanent stay is planned. So-called incoming travel insurance can also contain such exclusions.

**Fees:**

75 €, payable either by Visa/Mastercard or in cash in DKK (approximately 560 DKK, depending on the exchange rate)

**Important information:**

Missing documentation delays the procedure and can result in your application being rejected. The embassy reserves the right to request further documents. Certificates, diplomas, etc. must be presented in the original with apostille/legalization.

Once all required documents have been submitted, the application and supporting documents will be forwarded to the competent German authorities at the applicant's intended place of residence and employment during his/her stay in Germany. **The processing time** is as a rule ca. 4 – 8 weeks, but can take longer in individual cases.

Please do not contact the embassy to check the status of your application during the normal processing period. Such inquiries are extremely time-consuming for the visa section and can thus not be answered.
